

2. MEMBERSHIP

4. VIDYANIDHI FUND

This Fund is used to disburse educational assistance to the needy members of our community. With the steep rise in the cost of living, the Sabha renders assistance to the parents to meet part of the cost of education of their school and college going children. The Sabha is helped in this endeavour by Shree Walkeshwar Kashi Math who have been donating Rs. 6,000/- for this purpose for the past several years. In addition, members support this cause most willingly in response to the appeal sent by the Sabha. This year, our members and well-wishers donated a sum of Rs. 57,979/-. The Sabha gave cash assistance of Rs. 58,850/- to 185 students.

5. MAHILA SHAKHA

The Mahila Shakha conducts several programmes from time to time. The Marriage Information Service has been getting good response for the eligible boys and girls get-together, and there is a growing demand from parents for holding more such meets at regular intervals. The 25th December Anand Bazaar and the 26th January get-together were the major programmes conducted by the Mahila Shakha during the reporting period. A detailed report of the Mahila Shakha's activities is printed elsewhere in this Report.

During the year, Rs. 30,000/- was collected by the Mahila Shakha as General Donations.

6. SPORTS PROGRAMMES

Sports activities have been promoted in a big way during the reporting period with the Blow Plast sponsored Cricket Coaching

Camps gaining popularity. The G.S.B. Sabha's 3rd District Level Open Carrom Tournament, conducted under the auspices of Mumbai District Carrom Association, was held at the Sports Pavilion. A special feature of this year's tournament was a full day fixture devoted for physically handicapped players. The tournament was sponsored by Voltas Ltd. A detailed report of the Sports Committee is printed elsewhere in this report.

7. BHAJANS / RELIGIOUS PROGRAMME

- (a) Pada-pooja was offered to H.H. Shrimad Raghavendra Tirtha Swamiji of Kashi Math Samsthan on 5th January '96. Pada-pooja was also offered to Shishya Swamiji of Kawle Math on 7th January '96.
- (b) The bhajans that are held every Friday evening at the Sabha's Office between 7.00 and 9.00 p.m. have become very popular. Apart from this, Bhajans are held on auspicious days like Kartik Ekadashi, Dassera and the first day of Swamiji's Chaturmas.

The Upakarma Homa (changing of the sacred thread) on 'Suta Punav' is held at the Sabha's office between 7 a.m. and 12 noon for which members are sent intimation in advance.

- (c) Bhajan Classes are conducted at the Sabha's office from Tuesday to Sunday.
- (d) The Annual Saptaha Bhajan at Shree Walkeshwar Kashi Math, Shri Rama Naama Bhajans at Shree Rama Mandir, Wadala and Ekha Bhajans at Shree Balaji Mandir, Kurla are the other religious activities inwhich the Sabha participates every year.

8. ACCOUNTS

During the year, the Sabha made a general surplus of Rs. 2,23,736/-. The support received by the Sabha from sponsors, advertisers and donors contributed to the surplus. Also, funds were generated from the various activities conducted and the sponsorship/sale of various educational publications which have been well received throughout the country.

During the year, the re-construction of the Compound wall demarcating the Sabha's ground from the neighbouring plot was taken up. This was essential to safeguard the investment made in the cricket pitch, to prevent thoroughfare and to safeguard the Sabha's property. The work was partially completed till March '96.

The I.M.Pai Hall is being increasingly used for various functions. The ground is given to schools and sports associations for their Annual Sports Days/ events at nominal reimbursement for cleaning etc.

REPORT - G.S.B.S. MEDICAL TRUST

The GSBS Medical Trust, started in a modest manner in the premises of G.S.B.Sabha's office in 1967, has grown into a full-fledged medical centre presently operating at Dasturwadi, Naigaum Cross Road, Dadar over an area of 3000 sq. ft. The Trust is an independent charitable organisation with Income-tax exemption u/s 80-G.

The Trust is managed by a Board Of Trustees of seven members, assisted by an Executive Committee and many medical practitioners who give honorary services to the Centre.

The facilities provided include: A Diagnostic Centre catering to all specialities, A fully equipped Pathological Unit, E.C.G., A Physiotherapy Unit, An up-to-date Dental Unit, A complete eye examination unit, E.C.G., sonography, A Well Baby Clinic, An up-to-date X-Ray Unit. Besides, the Trust also implements several schemes such as Complete Medical Check-up Scheme with concession to Senior Citizens, Free Drug Scheme for very poor patients, lending of bed side appliances and free innoculations on Sundays.

The facilities are meant especially for the middle and lower income group of people of all communities and are therefore charged at nominal rates. The Medical Trust has a special Poor Patients Fund to help the poor patients with free medicines.

The members of G.S.B. Sabha are given 50% concession in charges for consultation only in the Diagnostic Centre.


